

Summary Annual Report
for

This is a summary of the annual report for the NV Energy Comprehensive Welfare Benefit and Cafeteria Plan, (Employer Identification No. 88-0198358, Plan No. 507) for the period January 1, 2024 to December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

NV Energy, Inc. has committed itself to pay the following types of claims incurred under the terms of the plan.

The plan has contracts with EyeMed Vision Care, EyeMed Vision Care, EyeMed Vision Care, EyeMed Vision Care, EyeMed Vision Care, EyeMed Vision Care, EyeMed Vision Care, MetLife Legal Plans, RELIASTAR LIFE INSURANCE COMPANY, Vision Service Plan, HARTFORD LIFE AND ACCIDENT, and EyeMed Vision Care to pay the following types of claims incurred under the terms of the plan.

All AD&D, Legal, Life, Indemnity & Vision claims

The total premiums paid for the plan year beginning January 1, 2024 and ending December 31, 2024 were \$5,067,612.

The value of plan assets, after subtracting liabilities of the plan, was \$94,032,738 as of December 31, 2024 compare to \$94,985,926 as of January 1, 2024. During the plan year the plan experienced a decrease in its net assets of \$953,188. This decrease includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$56,980,353. This income included employer contributions of \$40,713,212, employee contributions of \$13,447,413 and earnings from investments of \$2,792,433. Plan expenses were \$61,173,094. These expenses included \$1,996,362 in administrative expenses and \$59,176,732 in benefits paid to participants and beneficiaries.
